As desired the required information in respect of Personnel Department is furnished below for posting the same on the official website:-

**Item No.22 Appointment against Cultural Quota/Sports quota/handicapped quota and Scouts & Guides quota.**

On Metro Railway special recruitment as outlined above is made only against Sports quota. No recruitment has so far been made by Metro Railway against cultural quota, scouts and guides quota etc. As far as Sports quota is concerned Metro Railway has been following Railway Board's instructions for recruitment of Sportspersons as circulated from time to time the latest being under their No.E(Sports)/2007/Policy/3 dated 30th March, 2007 as per this Metro Railway's quota to recruit sportspersons is as under

The above quota is prescribed for each financial year. However the actual recruitment is dependent upon availability of vacancy in a particular financial year. Such recruitment is done by a committee specially constituted for this purpose and is coordinated by Metro Railway Sports Association (MRSA).

**Item No.23. Appointments On Compassionate Ground-**

The detailed instructions on the subject are available on the website of the Ministry of Railways(Master Circular No.16). However, the salient points are appended below:

1. Employment assistance on compassionate ground is offered to the wife /son/daughter of a Railway servant who dies while in service (accidentally/normally), or is medically incapacitated and declared unfit for all posts/categories.
2. The applicant should be dependent upon the ex. Railway servant as per the Pass Rules
3. The minimum eligibility condition (educational qualification) for appointment in Gr.D category is class VIII passed and in Gr.C is Madhyamik/Matriculation standard provided that no such minimum educational qualification is insisted upon in the case of the appointment being made in favour of the widow.
4. The application is required to be made in the proforma enclosed as Annexure-A.

5. The following information/documents are to be submitted alongwith the application:
- i) Election Commission/Voter Identity Card of the deceased employee, Widow, Son/Daughter (applicant).
  - ii) Ration Cards as above.
  - iii) Residential Certificate from Local Administration (Municipality Chairman, Councillor/Panchayat Pradhan/Mukhia or any Govt. Officer).
  - iv) Photograph of the candidate (Passport size) 4 copies.
  - v) Details about-Dwelling house, Landed Propety, Source of income.
  - vi) Prescribed Form for appointment on Compassionate ground is to be filled up by the applicant alongwith all educational certificates (Admit Card, Mark Sheet, certificate) in duplicate and duly recommended by the Local Administration and Controlling Officer of the deceased employee.
  - vii) During Spot Inspection of the Death Case the information as per attached form are to truly given to make the proper report by the Welfare Inspector.

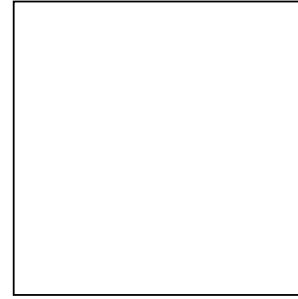

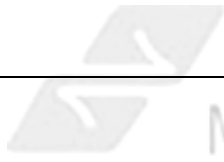

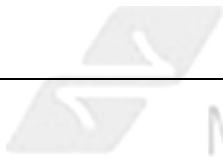
